PLANNING

Plot 1

This part of the scheme currently has approved permission for erection of a three-story office block. This has been partially implemented within five years of the date of decision, and as such therefore permission remains extant in perpetuity.

Planning has also been approved in 2019 to replace the original proposed office development with six twobedroom apartments over three stories.

Plot 2

This part of the scheme has received local planning officer's recommendation for approval for eighteen build-to-rent two-bedroom apartments set over three stories.


